CHAIR'S STATEMENT

2020 was an unusual and interesting year for the Christmas Bureau of Edmonton. It was a difficult year for many – our clients, our donors and supporters, and our volunteers. It was year like no other that we have experienced, but I am so honored to know that our supporters came through for those in need. Your continued commitment is heartwarming.

On behalf of the Board of Directors, I would like to thank everyone who contributed to the Christmas Bureau food program and the Adopt-A-Teen program in 2020. Together, we were able to help 35,680 Edmontonians and were able to raise \$1.5M for the food program and \$293K for the Adopt-A-Teen program during our modified Christmas Campaign.

Because of COVID-19, we did modify our giving program and delivery. With the uncertainty of how COVID-19 health restrictions might impact our delivery and wanting to ensure that all volunteers, clients and staff were safe, the Christmas Bureau suspended the Hamper Program and the Private Sponsor Program. For 2020, all approved clients received food gift cards. The Adopt-A-Teen program, which provides a gift card for teens aged 13 to 17 years, did not see an operational change.

The Christmas Bureau is fortunate to have such a strong network of volunteers, donors, fundraisers, and sponsors who make our work possible every year. The festive season is one of caring and sharing and one of neighbour helping neighbour. Your work demonstrates the generosity of Edmontonians to people in our community who desperately need it.

There's no question that what we do has an impact. We hear it in the voices of clients who give their thanks; we see it on the faces of clients that accept our hampers; we feel it as volunteers when we know we've made a difference. Thank you for helping us to continue our mandate of making sure no one has an empty plate at Christmas.

PROGRAM OVERVIEW

In 2020, the Christmas Bureau provided 35,680 people with a festive meal. 50% of those we served were under the age of 18.

Families make up 69% of those we served ranging in size from 2 to 15; 10% were seniors; and 21% were individuals.

7,701 families, 2,294 individuals, and 1,190 seniors were supported with food gift cards. Through our Adopt-A-Teen program, 4,270 teens, aged 13 to 17, received a \$50 gift card.

In partnership with 630 CHED Santas Anonymous Inc., 13,458 children received gifts. These children were registered through our application process.
